SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. not less than 5 percent of the total amount of grant funds awarded to the State (\$449.4 million) to carry out activities to address the impact of lost instructional time by supporting the implementation of evidence-based interventions;

not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based summer enrichment programs; and

not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based comprehensive afterschool programs.

Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. We have been discussing re-opening since winter 2021. Parents have been involved through open board meetings, school-to-home regular conversations, and our emailed newsletter. To develop a plan for our ARP funds, we engaged a diverse set of stakeholders that represent the students we will serve with these funds. We accomplished this by providing a survey seeking the input of our stakeholders, including families, staff and faculty, and school leadership, on the use of our funds. The survey included an opportunity for respondents to express their priorities for supporting students as they return to school after COVID-19. The survey was sent to our community in November 2021, including staff and parents of students with disabilities, English language learners, economically disadvantaged students, and other at-risk populations. In addition, we posted a link to the survey on our website, allowing for anyone to contribute feedback. We used the results of this survey to design our plan for spending ARP funds. We will conduct another survey in 6 months to ask for input on ARP implementation.

We use these data sources to assess progress and inform our school program for all students, including students with disabilities, English language learners, economically disadvantaged subgroups, and other at-risk populations. Following the administration of AIMSWeb, STEP, and NSGRA assessments, data meetings take place with teachers, Response to intervention (RTI) team, VP and instructional coach to discuss what the data is telling us about scholars' learning and progression in the classroom. Together decisions and recommendations are made about Tier groups and Guided Reading (GR) groups. Students demonstrating increased social and emotional needs are supported by our school counselors. Our Intervention Specialist closely tracks the progress of students receiving interventions and adjusts student plans accordingly. Intervention tools/resources used at BCCSB include: Focused Reading Instruction; Focused Math Instruction; Number Worlds- Math; Level Literacy Intervention (LLI); Newmark Learning Program; Reading Mastery; Envisions Math/ Intervention Kits; Sadlier Phonics; Words Their Way; Wilsons Foundations; Florida Center for Reading Research; Intervention Central; Wonders Treasures; NewsELA.

We are allocating ARP ESSER to support the following positions:

Parent Coordinator (1) [We employ a Parent Coordinator to focus on serving parents and any special family needs.

Counselor (1) School counselors are in charge of implementing our school's social emotional learning (SEL) program, Second Step. While they have several roles within the school, the main focus was recently revised to ensure all scholars are emotionally and socially competent.

Educational Assistants (3): Supports teachers in the classroom and allows for small group work, a critical component for addressing learning loss.

RTI Teacher (2) An RtI Core Team is in place to monitor the progress of scholars within the RtI system. Each Intervention Specialist within the team is assigned a particular number of scholars. It is the Intervention Specialist's responsibility to examine the AIMSweb and other diagnostic data for each of the scholars assigned to them in order to set measurable and obtainable goals at the start of each intervention session. Scholars' progress through these goals is observed through weekly progress monitoring in Tier III, and bi-weekly progress monitoring in Tier II. If a scholar is not making sufficient progress toward his goals after four data points, or if he has achieved his goals, the goals will then be modified. RtI staff and classroom teachers meet during common planning time, data meetings, and during professional development days to discuss the data.]

SPED Teacher (2) [The SPED teachers collaborate with general education teachers to identify and assess students who may have disabilities or special needs. Following students' Individualized Education Programs, they provide instruction to meet the needs of each student.]

Behavior Intervention Specialist (1) Under the supervision of the Assistant Principal, the Behavior Intervention Specialist is responsible for monitoring and enhancing student behavior at BCCS-Boys. He/She supports the Assistant Principal with administering disciplinary procedures in accordance with the school and state law policy for in-school and remote instructions. He/She helps to foster a positive, engaging and caring atmosphere, and a healthy BCCS-Boys community that enables scholars to flourish. The Behavior Intervention Specialist proactively and effectively communicates with parents. He/She is focused on building BCCS-Boys' programming that embraces and teaches the PICS values of our school: Perseverance, Integrity, Citizenship and Scholarship.

All of our funds have been dedicated to learning loss for all years. There were no other areas of focus with this particular grant.

We will ensure that the interventions we implement, including but not limited to the interventions implemented under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time, will respond to the academic, social, emotional, and mental health needs of all students, and particularly those students disproportionately impacted by the COVID19 pandemic, including students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students.

- **Academic needs for at-risk students:** The following supports are in place at BCCCS-B to support all students, including those with specific learning needs:
 - We employ a Parent Coordinator to focus on serving parents and any special family needs.
 - We offer an incentivized attendance program for scholars with low attendance.
 - We have an extended day and school year.
 - Integrating technology in the classroom in order to connect with scholars of all learning styles.
 - Integrating technology in the classroom that would allow for more scholar engagement.
 - We employ a full time ESL teacher. In addition, our support staff includes one School Counselor, two Student Success Coordinators, two RtI teachers, An Intervention Coordinator, and three SPED-certified teachers.
 - We recruit prospective staff members who are bilingual and can support families of ELLs.
 - We continue to build capacity with current staff to service the needs of ELLs through professional development opportunities with CASDA and University of Albany and opportunities for collaboration with the ELL teacher at BCCS-G.
 - We joined a Title 3 consortium to allow our school to collect title 3 funds to help ensure that ELLs attain English language proficiency and meet state academic standards.
 - We promote disability inclusion as an organizational value conveying the message that our organization values diversity and inclusion and that we foster a commitment to including people with disabilities at all levels of our organization.
 - We ensure that disability-inclusive policies are communicated to all staff members so that all are well informed and can confidently communicate and answer questions about services we have in place for students with disabilities.
- **Social-emotional needs for at-risk students:** We offer social and emotional health programs to support children living with the effects of poverty.
- We held a training in "Caring for Children Who Have Experienced Trauma" in 2019-20. We will continue to expand our capacity in this area as we re-enter school, in anticipation of scholar needs in light of the COVID-19 pandemic.
- **Mental health needs for at-risk students:** We recognize and respond to scholar mental health needs and assist scholars and families seeking resources. If warranted, we provide referrals to support scholars and families to school or community resources for additional assistance and information. We provide direct services in the form of short-term individual and group counseling, crises responses and Tier-level programming:
 - Counseling: may take place in an individual or a group setting. Counselors provide planned, short-term and goal-focused counseling.
 - Crises Responses: provide support and assistance to scholars and families as they navigate crises and emergency services
 - Implementing Tier level programming: i.e. counseling, observations, class plans, screenings for emotional incompetence, assemblies/classroom lessons, facilitate community-school engagement opportunities, SEL, etc.
